Through this leadership, staff was able to form partnerships and be more involved with other organizations and projects.

This area of Putnam County has very little resources. EnAct, Inc. along with other leaders of this community, such as teachers, FFA (Future Farmers of America), Toyota, WVU Extension, and Lowe's wanted to prepare these families to never go hungry by teaching them how to grow their own food. All of the students at Buffalo Elementary will have the opportunity to participate and learn this skill.
